BABLE CAUSE AFFIDAVIT

(specify probable cause for each charge)

Before Me, the undersigned authority personally appeared DEPUTY J. BRIDGES who being duly sworn, alleges, on information and belief that on the 15TH day of MAY, 19 93 in HERNANDO County, Florida, the defendant did:

UNLAWFULLY COMMIT SEXUAL BATTERY UPON (6)
YEAR OLD WHITE FEMALE VICTIM C. JONES, BY
PENETRATING THE VICTIM'S VAGINA WITH HIS FINGER,
IN VIOLATION F.S. 794.011(2)

ON 05-15-93, AT 1043 HRS. WRITER RESPONDED TO
A DEPARTMENT OF HEALTH AND REHABILITATING SERVICES,
SHELTER LOCATED IN BROOKSVILLE FL. REFERRING TO
POSSIBLE CHILD ABUSE.

UPON ARRIVING I MADE CONTACT WITH H.R.S. PROTECTIVE
INVESTIGATOR ISABEL HARRIS. MRS. HARRIS ADVISED
THAT SHE WAS NOTIFIED BY SHELTER PARENT, DORTHY
STENSTROM OF A INCIDENT INVOLVING (2) TWO OF HER
SHELTER CHILDREN, MRS. STENSTROM ADVISED MRS. HARRIS
THAT 6 YEAR OLD C. JONES CAME INTO MRS.
STENSTROM BED ROOM AT 2300 HRS ON 05-14-93, AND
ADVISED HER THAT SHE FELT SICK. MRS. STENSTROM FURTHER
ADVISED THAT C. JONES THEN LEFT THE BED ROOM AND THEN
CAME BACK ADVISING SHE WANTED TO TALK TO HER
FATHER, BECAUSE SHE HAD BEEN DOING BAD THINGS.

MRS. HARRIS INTERVIEWED C. JONES, WHEREAS SHE
STATED THAT T. HALL KISSED HER ON THE LIPS AND RUBBED
HER. MRS. HARRIS ASKED C. JONES TO SHOW HER WHERE
T. HALL RUBBED HER, C. JONES POINTED TO HER VAGINA.
T. HALL SAID THAT HE DID PLACE HIS RIGHT HAND
INTO VICTIM'S UNDER PANTS AND PENETRATED HER VAGINA
WITH HIS FINGER.

Petitioner, BRAD KING, State Attorney for the Fifth Judicial Circuit of Florida, by and through the undersigned Assistant State Attorney, respectfully represents to the Court that [REDACTED], residing at Marion County Detention Center, 3040 NW 10th Street, Ocala, Florida 32678 and/or 2315 Hwy 41N, Inverness, Florida 34453, and a male child of the age of fourteen years, is alleged to be a delinquent child within the intent and meaning of Chapter 39, Laws of Florida, by reason of the following alleged violation(s) of Laws of Florida, to-wit: that on or about the 14th day of May, 1993, in the County of Hernando and State of Florida, the said [REDACTED]

did, being a person eighteen (18) years of age or older, unlawfully commit sexual battery upon [REDACTED], date of birth: 5-23-86, a person less than twelve (12) years of age, by causing his finger to penetrate the vagina of [REDACTED], in violation of Florida Statute 794.011(2);

COUNT II

and the Assistant State Attorney upon his oath aforesaid, further information makes that [REDACTED] in the County of Hernando, and the State of Florida, on or about the 14th day of May, 1993, in the County and State aforesaid [REDACTED]

did unlawfully handle, fondle or make an indecent assault upon a child under the age of sixteen (16) years, to-wit: [REDACTED], date of birth: 5-23-86, in a lewd, lascivious or indecent manner, in that he did fondle or rub the vaginal area of [REDACTED], in violation of Florida Statute 800.04(1);

The legal custodian of said child is/are RALPH HUNTER who reside(s) at 2315 Hwy 41N, Inverness, Florida 34453, and the parent of said child ANNA V. HALL, 200 Robin Hood Road, Inverness, Florida 34450.

The said child is now in the care and custody of MARION COUNTY DETENTION CENTER whose relation to said child is that of custodian.

Wherefore your Petitioner requests that the Court summons the said parents or legal custodian to appear personally and bring said child before the Court at such time and place as the Court may designate.
