Request to take notice of Constitutional violations

Dear Sir or Madam:

I, Dewey H. Jones, only have an eighth grade education. The following is a true statement of facts with evidence attached.

- 1. On May 31, 1988 I was injured at work, total disability for life. Had this not have happened I would not know any of the following because of working 8 hours a day plus 2 hours driving time. I noticed some weird things that the mother of my children was doing to them. On April 09, 1992 I had the mother contact Hernando County Mental Health stating that I was going to injure myself so that I could get outside help. Please note that this woman had me on multiple medications claiming to the doctors that she was a nurse and was given directions on how to dispense them but she did not dispense them as directed. Also spiking my water with alcohol that she knew I was allergic to. See all three documents from Hernando County Mental Health attached.
- 2. On May 22, 1992, I was arrested and taken to jail for domestic violence. This particular night was a birthday party for my four year old little girl. I great pain to make my little girl happy, I used crutches to get from the bed to the couch. As I sat on the couch the mother stabbed me in the back and then grabbed a cast iron pot full of boiling water and cooked noodles and dumped them in my face then hit me in the head with the hot pot. Also attached are pictures showing my proximity to the stove. As you read the police report attached that was from that night, she states that "she handed the sauce pan with noodles to Dewey". A year later, my then four year old son stated, "My mommy dumped macaroni on my daddy's head one time, banged him on the head with a pan and gave him a headache." See documents attached.
- 3. Attached also is a summary of my medical history to date for that time period which shows that I was bedridden and on narcotic medication. In the civil trial the mother stated in court records that I drove down and bought a gallon of whiskey. Under the condition I was in I was barely able to get out of the bed much less drive.
- 4. On May 22, 1992, as soon as I was able I called 911. (Note: we had the phone for two days, HRS forced her to get it.) They arrested me and I went to jail while they allowed her to leave the state with my two children. All this was premeditated because she already had the vehicle packed with all her and the children's belongings. And called the sheriff 45 mins later stating she had left the state.

- 5. The mother conspired with a neighbor for collaboration. The neighbor mother abused her daughter to say things about me that were false. And for hours the sheriff question this child and tampered with the witness. See attached sheriff records of the false allegations against me that she was never charged with. This neighbor mother was separated from her daughter and the daughter filed for child support. See documents attached.
- 6. On May 15, 1993, a man/child 6'1" and 165 lbs 14 ½ year old raped my baby girl. The arrest probable cause affidavit of this man my baby girl told the sheriff she wanted to talk to her father about the bad things she had been doing. See attached document.
- 7. On April 6, 1992 I was arrested for capital sexual battery of a minor and several lessor charges. They changed these charges four times without the benefit of a grand jury, on June 6, 1994 under the prosecutor doctor of the county jail gave me my full day's narcotic medications and forced me to take them all first thing in the morning before going to court. When I got back to the jail Nathan Brown informed me of what they had done and helped me file a motion to withdraw the illegal plea. See attached documents. Three days later I was in prison for a crime I never committed.
- 8. On April 6, 1992 I was appointed public defender Stephen Toner. For nine months he never once came to see me. On the ninth month he withdrew his representation of me because he represented the man who raped my baby girl. On this day I was assigned ex-prosecutor Chip Harp who was going through a divorce and his wife took everything and this man wanted me TV for payment for answering my questions. He got \$14,500.00. John Viltola got \$14,500.00, James Brown got \$14,500.00 for representing me. Just to plea me out while under narcotics.
- 9. I, Dewey H. Jones, had no bond, no grand jury indictment for the capital crimes, no lawyer for 9 months, no equal protection of the law, charged with alleged multiple accounts of the same offense, cruel and unusual punishment based on the fact that Dewey H. Jones never committed a single act of assault against anyone and deprived of my freedom by incarceration and sex offenders list to be imprisoned in his own home for life because of the three day rule. Every time the sheriff comes to my address "spot check" to make sure I am still here is like a slap upside the head saying we can kidnap and rape your child and you can do nothing about it. This is why I haven't given up yet.

Conclusion
